Why Become a Hunt Hill Member?

What category of Membership do I/we fit into?

Individual: **\$30 per year.** This is a “per person membership” entitling the individual to the member benefits.

Family: **\$60 per year.** This membership is for immediate family members, defined as parent(s) and all children under the age of 18, entitling each family member to the membership benefits listed above. (SPECIAL NOTE: Seniors joining under a Family Membership may include grandchildren in their immediate family, in place of their adult children.) This is the only membership level that includes youth.

Senior/Student: **\$20 per year.** This is a “per person membership” for those over the age of 55/those enrolled in higher education, entitling the individual to the membership benefits. (SPECIAL NOTE: Seniors joining under the Family Membership may include grandchildren in place of their adult children.)
